Both the Regular Checking and NOW Checking Accounts provide for an unlimited number of withdrawals. The Basic Checking account provides for twelve (12) withdrawals per month. Each withdrawal above this limit will incur a per item fee of one dollar ( $\$ 1.00$ ). Money Market and Statement Savings Accounts provide for unlimited withdrawals in person, by mail, by ATM, or by messenger. By law, you are permitted up to six (6) other withdrawals per statement cycle including checks (in the case of Money Market Accounts) and preauthorized or automatic transfers.
${ }^{(*)}$ The monthly fee will also be waived if you maintain a $\$ 2,000$ average monthly collected balance in linked accounts. All balances are calculated based on the average monthly collected balance.

## BUSINESS ACCOUNTS

Business Checking Accounts will incur a monthly maintenance fee of fifteen dollars (\$15.00). All items, including, but not limited to, checks deposited, deposit tickets, checks paid, and other withdrawals, will incur a per item charge of $\$ 0.15$. An earnings credit of $\$ 0.20$ per $\$ 100.00$ will be applied to collected balances. The earnings credit will be used to offset the above maintenance and transaction charges. An average monthly collected balance of $\$ 7,500.00$ will offset the monthly maintenance fee. Business Money Market and NonPersonal Savings Accounts will incur a monthly fee of ten dollars (\$10.00). If the average monthly collected balance in the account is at least $\$ 5,000.00$, the monthly fee will be waived. Money Market and Savings Accounts provide for unlimited withdrawals in person, by mail, by ATM, or by messenger. By law, you are permitted up to six (6) other withdrawals per statement cycle including checks (in the case of money market accounts) and pre-authorized or automatic transfers.
